7. Primary Objective

The primary objective of the Marine Environmental Compliance & Enforcement Officer (Marine Officer) is to safeguard the marine environment and its resources through diligent enforcement of marine environmental laws, regulations, and policies. This includes monitoring activities, investigating violations, promoting conservation, responding to emergencies, and collaborating with other relevant agencies.

The Marine Officer is answerable to the Director of Marine and is responsible for ensuring compliance with National Maritime Laws and Regulations, as well as International Maritime Conventions, Protocols, Codes, Conditions, Rules, and Standards, including the MARPOL conventions and greenhouse gas (GHG) emissions regulations.

In addition, the Officer is tasked with enforcing the National Action Plan on the Prevention of Marine Oil Spills within Kiribati waters. As required, the Marine Officer may also undertake additional technical and administrative duties as assigned by the Director of Marine, with the aim of preserving and protecting the valuable marine resources of Kiribati. The Officer may also conduct inspection and survey of ships to ensure compliance with relevant regulations.

8. Position Overview

The Marine Environmental Compliance and Enforcement Officer is responsible for enforcing marine environmental laws, regulations, and policies in order to protect and preserve the marine environment and its resources.

The Officer is also responsible for responding to emergencies and collaborating with other relevant agencies to promote conservation efforts. Additionally, the Officer is responsible for ensuring compliance with the MARPOL conventions, greenhouse gas (GHG) emissions regulations, and conducting inspections and surveys of ships to ensure compliance with relevant regulations. The Officer will also be responsible for developing and managing GHG policy related to maritime activities.
